

Pinedale Winter Carnival Cardboard Classic Race Waiver

*Each individual racer on your team needs to have a signed waiver attached to your registration form prior to the race.

I, the undersigned, hereby acknowledge that I have voluntarily consented to participate in the Pinedale Winter Carnival Cardboard Classic Race event organized and hosted by Main Street Pinedale. I understand, and am aware that the above referenced activity is a potentially hazardous activity. I am voluntarily participating in this activity with knowledge of the danger involved and hereby agree to accept any and all risks of injury or death. I agree that I am solely responsible for any injury to myself or any other person due to my participation in the above-mentioned event and activity.

I agree, that I am solely responsible for my own safety while participating in this event and/or any other activities associated with this event, and I am free to refuse to participate in these events for any reason.

Furthermore, I understand and accept that racing in a cardboard craft involves numerous inherent risks of injury or death including, but not limited to, loss of control, collisions with trees, rocks, fencing, spectators, volunteers, other participants, man-made snow retainer walls, and other crafts or natural obstacles.

I understand that I am voluntarily choosing to participate in the Pinedale Winter Carnival Cardboard Classic Race event with knowledge of the aforementioned risks of injury and hereby agree to accept and assume all risks of injury or death associated therewith.

I understand that safe and sportsmanlike conduct is required to participate in this event. If a contestant is deemed unsafe according to these terms, they may be disqualified and will not be allowed to compete. I further understand that participating while under the influence of alcohol and/or illicit substances is not endorsed and is highly discouraged for my own safety and that of others. Main Street Pinedale reserves the right to disqualify and prevent anyone from competing that is deemed unsafe due to the consumption of alcohol and/or illicit substances. The determination of whether a participant is unsafe according to these terms is within the discretion of Main Street Pinedale.

AS LAWFUL CONSIDERATION FOR MY BEING PERMITTED BY MAIN STREET PINEDALE AND THE TOWN OF PINEDALE TO PARTICIPATE IN THE PINEDALE WINTER CARNIVAL CARDBOARD CLASSIC RACE, I HEREBY AGREE TO THE FULLEST EXTENT ALLOWED BY LAW, TO RELEASE FROM ANY LEGAL LIABILITY AND TO DEFEND, INDEMNIFY AND FOREVER HOLD HARMLESS AND AGREE NOT TO CLAIM AGAINST OR SUE MAIN STREET PINEDALE, ANY BOARD MEMBERS OR VOLUNTEERS INVOLVED WITH MAIN STREET PINEDALE INCLUDING THEIR HEIRS, ADMINISTRATORS, SUCCESSORS, AND ASSIGNS, OR ANY POSSIBLE PARTNERS, AGENTS, LANDOWNERS, VENDORS, FOR ANY AND ALL DAMAGE, INJURY OR DEATH TO MYSELF OR TO ANY OTHER PERSON OR PROPERTY, WHETHER CAUSED BY THEIR NEGLIGENCE OR FOR ANY OTHER REASON.

I am aware that I am releasing certain legal rights that I otherwise may have, and I enter into this agreement on my own free will. This agreement shall be legally binding upon me, my heirs, my estate, assigns, legal guardians and my personal representatives.
